- Electricity Consumption Charges: Power consumption charges for the full exhibition period are Rs. 3,500/- per KW per connection payable in advance before 15th Feb 2026.
- Payment: up to 31st Oct 2025 30% of Full participation charges payable as advance along with the application in favor of ELECTRICAL CONTRACTORS' ASSOCIATION OF MAHARASHTRA - A/c payable in MUMBAI. After 31st Oct 2025 the advance along with booking will be 50%, and the remaining amount + Taxes + Electricity charges will be pay before 15th Feb 2026.
- Allocation of Space: Space allocation will be done by the Organizers on first-come-first-served basis, only on receipt of complete application along with requisite payments. Space will be allotted only to participants and no subletting will be allowed. The decision of the Organizers will be
- Possession of Space: Possession of Space will be given only on receipt of the full payment including participation charges, electricity and additional requirement charges. Possession will be given on 02nd Evening for bare space applicants and on 3rd of Morning Shell Scheme applicants. Display will have to be completed 2 hours before the opening of the Exhibition.
- Rs. 2000 per sqmtr is security deposit charges are applicable in the case of bare space stall installation will be executed by 3rd party vendor.
- Operation of stands: No stand will be left unattended during the exhibition. Staff of participants must be present at least half an hour before the opening and half an hour after the closing of the exhibition. No activity, in the opinion of the organizers amounting to nuisance, annoyance will be caused by the participants. The Organizers shall have the right to take remedial action in such cases. Exhibits must not obstruct passages, Fire extinguishers, cable terminals for telephone connections, outlets for electricity and water.
- 10. Vacation of Space: Space will have to be vacated immediately after the closure of the exhibition, failing which, participants will be required to pay a penalty as prescribed by BEC and the organizers will have the right to remove the exhibits/material of participants, at their own risk, cost and consequences.
- 11. Storage of exhibits in the open area will not be permitted after the closure of the exhibition, and a penalty rent of Rs. 1,000 per sqm per day will
- 12. Storage of Empty Cases: Empty cases will not be allowed to be kept anywhere in Bombay Exhibition Centre (BEC). These will have to be removed at least 12 hours before opening of the exhibition. Agency is provided for handling empty cases to clear and return their empty cases
- 13. Security: The Organizers will make general security arrangements. However, participants will be responsible for the security of their exhibits and stall. They will make security arrangements of their stalls through Security Agencies approved by the Organizers.
- 14. General Safety: Participants should ensure that all electrical wirings, fittings, appliances, etc in the stalls are as per applicable safety standards. Public safety is of paramount importance and no live wire, exposed fire should be left unattended in the booths.
- 15. Fire Prevention: Participants will keep and maintain firefighting equipment in their stalls as per safety regulations. Arrangements of fire extinguishers in stalls is the responsibility of the individual participant.
- 16. Insurance: Participants will insure their exhibits, display material against loss, damage, theft, fire or any cause whatsoever. They will also obtain 3rd party insurance cover for construction period, exhibition period and dismantling period.
- 17. Service Agencies: Work of cargo handling, construction of shell stand, furniture hiring and catering can be availed by the participants only from the Contractors appointed by the Organizers. Exhibitors with bare space can appoint their own Contractors for stall construction.
- 18. Damages to the Halls: Exhibitors will be required to make good all damages or make payment for damages in the halls, if any.
- 19. Entry/Exit: Entry into Bombay Exhibition Center (BEC) will be on the basis of exhibitor passes issued by the Organizers. Each exhibitor will be entitled to 3 passes for a minimum of 9 sqm. space and 2 passes for every additional 9 sqm. Exit passes will be necessary for exhibits/materials to be taken out of BEC. Free Entry for Visitors.
- 20. Non-payment of full participation fees before 15th Feb 2026 will amount to cancellation without reminders. Advance paid by the participants in such cases will be forfeited.
- 21. Cancellation of Space booked is not allowed and no request for refund will be entertained.
- 22. Legal Disputes, if any, shall be within the jurisdiction of the court in Mumbai.
- 23. Food & Parking: For Exhibitors and Visitors, Cafeteria Food charges and Vehicle Parking charges extra as per BEC norms.
- 24. Force Majeure: If the Exhibition is abandoned, cancelled or suspended by reason of war, fire, national emergency, non-availability of exhibition premises or any other cause not within the control of the Organizers, the Organizers may, at their own discretion, refund the participation charges paid by the exhibitor after adjusting the administrative expenses incurred, but the Organizers shall be under no obligation to refund any charges and shall be under no liability for any claims or losses.
